Trinity Services launches new Living Room program to help people cope with mental health crises in comfort

rinity Services, Inc.'s Living Room is an innovative new program in Orland Park that gives people in crisis a safe, welcoming environment to cope with mental health or daily life stressors.

The program officially opened this spring and held a Virtual Open House May 18, during which attendees took a virtual tour of the space, heard from Living Room staff members and asked questions about the program.

Trinity's Living Room is part of the Illinois Department of Human Services'

Division of Mental Health Living Room Program. There are approximately 20 similar programs throughout the state, and Trinity Services is proud to be part of this new initiative in mental health care.

The Living Room aims to divert people in crisis from emergency rooms and provide them with a comfortable, homelike environment in which to process the crisis, and learn and apply wellness strategies.

Approximately one in five people visit an emergency room each year. Of

Remembering Ken Stromsland, longtime Trinity Services board member and volunteer

en Stromsland devoted countless hours of his time and expertise to people supported by Trinity Services over the past nearly 50 years, and today, Trinity honors his memory.

Stromsland passed away April 29, 2021 at age 81 after a courageous struggle with Parkinson's disease.

He joined the Trinity Services Board of Directors in the early 1970s. An architect by trade, Stromsland advised the organization on construction projects and played an instrumental role on the search committee that found and hired Trinity's former President and CEO Art Dykstra in 1987

Board Chairperson Raymond Mc-Shane remembers Stromsland as a very kind, giving person who was actively involved in the community. He knew Stromsland from his active presence in the Joliet area business community and his involvement with community events, including the creation of Bicentennial Park in Joliet.

"He's done a lot of work for the organization over the years," McShane said. "He did research on some of the developments that Trinity has, and he always got involved in any of our construction projects."

Stromsland enjoyed raising and showing horses, and he was involved in the creation of STRIDES, Trinity's therapeutic horseback riding program.

Over the years, he served in officer positions on Trinity's Board. He was passionate about ensuring that Trinity had the best facilities possible to use to support people.

"He was always making sure everything was safe in our buildings," McShane said. "Ken loved horses, so that re-

ally gave us a head start when we started the STRIDES program. He was very available to make sure that everything was great for all of the people we support."

In addition to his work with Trinity Services, Stromsland was a school board member of the Homer grade school district, a member of the Joliet Exchange Club, a board member of Shepherd of the Hill Lutheran Church, a member of the Hilltoppers Field Trial Club, a member of the Paso Fino Owners and Breeders Association, Inc., and a member of the local Paso Fino club. He was a principal and

owner of Stromsland & DeYoung Architects and a long-serving member of the American Institute of Architects Eastern Illinois Chapter.

Stromsland is survived by wife Judy (nee Hausermann), children Kari (Todd Willsie) Stromsland, Susan (John) O'Connor, Peter (Susan) Stromsland and Eric (Kim) Stromsland, and grandchildren Katie and Jason Stromsland.

"He made sure that we had a good understanding of the direction we were heading into," McShane said. "We really valued all of his input and guidance. He was a great person."

those, 4 percent visit for symptoms of a mental illness or substance abuse disorder.

"The emergency department is really not an ideal environment for mental health crises," Program Director Carl Indovina said. "The emergency room can be very traumatic for someone who is already struggling with a mental health crisis."

Because of the high demand on emergency departments and their staff, people in crisis are often left alone in those environments.

Alternatively, the Living Room is staffed by recovery support specialists — people who have experienced and overcome crisis situations in the past — and therapists who attend closely to the needs of visitors, providing them with a safe, inviting, non-clinical, non-judgemental space to process a crisis.

Therapists screen guests upon ar-

rival and prior to departure from the program, and recovery support specialists provide individualized support and counseling during a guest's visit. Recovery support specialists are able to provide relatable support, as they have gone through and overcome crisis situations in the past, themselves.

Guests may visit the Living Room on their own or may be referred to the program by emergency services personnel. All visits are free, and no insurance information is needed.

"We try to make this a place that is like coming to visit a supportive friend," Indovina said. "We refer to persons using our services as guests. We are very person-centered. We welcome guests as guests. Just as you'd invite guests into your home to talk and for a cup of coffee, we invite guests here to talk when they visit the Living Room."

The Living Room is designed to feel relaxing, equipped with comfortable furniture, refreshments, books, carpeted floors, artwork on the walls and soft lighting.

Trinity Services' Living Room is open 7 days a week, 365 days a year from 10:30 a.m.-8 p.m. and is located at 14315 S. 108th Avenue, Suite 222, in Orland Park, IL. Jenny Cohen joins Trinity's Executive Committee

rinity Services, Inc. is proud to announce that Jenny Cohen has joined the organization's Executive Committee as Director of Residential Network V.

This network encompasses 11 group homes, or community-integrated living arrangements, in the Joliet area. As Cohen assumes this role, Lisa Dillon, former Director of Network V, becomes Director of the newly created Residential Network X, overseeing the Trinity Living Centers, which are intermittent care facilities for people with developmental disabilities (ICF/DDs).

Cohen and Dillon previously worked closely together as associate director and director, respectively, of Network V. This change will allow both leaders to focus on the specialized needs of the people they support and the types of residential settings they oversee. The Trinity Living Centers follow guidelines from the Illinois Department of Public Health, and group homes follow guidelines from the Illinois Department of Human Services. People who live in the Trinity Living Centers also require greater medical attention for health concerns than people who live in group homes.

Additionally, the Trinity Living Centers have different shift schedules from group homes, and this new departmental structure will help address some of the challenges created by staff-

ing shortages.

"I believe this redistribution of oversight will be beneficial to Trinity and will allow both Jenny and Lisa to focus their attention at a time when resources are scarce," said Thane Dykstra, Ph.D., President and CEO of Trinity Services. "The Living Centers, by virtue of their oversight by Public Health, require specialized knowledge to ensure their compliance with the pertinent regulations."

Cohen has devoted her 21-year career to helping people live full, abundant lives at Trinity Services. She said what she looks forward to most about this promotion is the ability to expand upon systems that she and Dillon were building together, and to look at the big

"I enjoy the opportunity to look at the structure of the department and train new people," she said. "I'm enjoying starting to look at those systems, and my associate director is new to Trinity. I'm excited about hearing people's fresh ideas on how we can continue to make this network better."

Cohen is a Chicago Ridge native and current resident. She became a counselor at the Oak Psychosocial Rehabilitation Program (PSR) after earning her bachelor's degree in psychology from Governor's State University.

Within a year, she was promoted to associate director of the program, and in 2003, she was promoted to director of the program. In 2010, she transferred to become director of the Hoff PSR. In 2016, Cohen moved into residential services as the associate director of Network V. She earned her master's degree in human services management in 2019 from National Louis University.

Cohen said she was always interested in psychology and learning about why people think and behave the way they do. As a teenager, she worked at a grocery store, and a coworker had a job at Trinity Services. He encouraged her to give the organization a try.

She did not previously have any experiences with someone with a disability and did not know what to expect. She did not think working at Trinity would become a lifelong career.

"Pretty quickly, like most of us here, I fell in love with the people we support," she said. "Here I am 21 years later. I love what we do."

As an associate director, Cohen supervised team leaders and qualified intellectual disabilities professionals. Now, as a director, Cohen is focusing on expanding on the structures that were in place, mentoring team members, and connecting with other residential network directors to collaboratively improve upon meeting the needs of people the organization supports.

Of all of her achievements in her career so far, Cohen said what stands out to her the most is helping people she supports accomplish their own goals.

Seeing somebody who came to us who had a very traumatic history and difficult behavioral challenges begin participating in a group therapy session — those kinds of things are really exciting," she said. "Seeing a person move into an apartment — seeing a person work toward a goal for so long, and then reach that outcome. I've learned to recognize the small steps people make.

"That is something that's been lifechanging for me. It's helped me in life with my kids and myself. It's a big deal when small steps lead to a huge outcome."

Cohen added that she is proud of getting her master's degree, particularly as she went back to school after raising her children as a single mom.

Looking ahead, Cohen's immediate focuses are on strengthening her team in Network V, mentoring new team leaders, and improving staff retention

in the department.

"I had the pleasure of working closely with Jenny for a number of years when I was director of the Trinity Behavioral Health program," Dykstra said. "I have confidence in Jenny's leadership ability and her commitment to agency values and quality standards. Jenny is passionate about working with people who are behaviorally complex. She has always been a strong advocate for the people she serves and the people she leads."

Outside of her career, Cohen enjoys spending time with her children and grandchildren. She also enjoys reading and attending concerts.

"I'm dedicated and committed to helping people live full, abundant lives," Cohen said. "I think we have to live and breathe it — not just say it."

National disability provider association names Terra Smith 2021 Illinois DSP of the Year

Professional at Trinity Services, Inc., is inspired by seeing smiles on the faces of people she supports when they achieve a goal or are having a good time. Recently, Smith has an achievement of her own to smile about, as the American Network of Community Options and Resources (ANCOR) announced that she has been named the recipient of the 2021 Illinois Direct Support Professional of the Year Award.

Smith joins 49 other recipients of ANCOR's 2021 Direct Support Professional of the Year Awards, chosen from a field of 350 outstanding nominees.

Smith has made a huge difference in the lives of people with intellectual and developmental disabilities since she became a DSP three years ago. The Chicago native and current Lansing resident was inspired to join the field after retiring from the Chicago Transit Authority and hearing about the impact her niece and son were able to make in people's lives through their work with Trinity Services.

As a DSP at a day program, Smith is well-versed in developing curriculum, and she pays attention to the personal values and needs of each person she supports to individualize the activities she facilitates for them. She has helped people explore interests in cooking, telling time, making video calls, fitness, and more.

"I ask people, 'What is it that you want to do?'" Smith said. "I follow their lead."

"When special activities requiring extra hours, such as cooking holiday meals, developing creative curriculum and completing elaborate projects present themselves, Terra is the first to contribute her own time to ensure the experience is exceptional," said Stephanie Behlke Leigh, Network Director at Trinity Services. "Her coworkers appreciate that she is concerned about all aspects of the program. Terra is always learning and bringing fresh ideas forward to make services the best they can be."

A couple years ago, Smith took vacation time for her birthday, which falls around Thanksgiving. Despite this, she came in to work to cook a Thanksgiving

meal at the day program to ensure that everyone had delicious food to enjoy. She prides herself on her cooking and wanted to help her coworkers out.

"This isn't always an easy job," she said. "Some days are very difficult. When I see my coworkers saying they are tired or need a break, I do what I can to fill in the gaps. We cover each other."

Smith also uses her ability to think creatively, outside of the box, to assist people with overcoming obstacles. For example, when someone was disengaged from activities going on at the day program, she learned that this person loved the color red. She began incorporating the color into materials, and the person instantly became more engaged.

When the COVID-19 pandemic hit and day programs closed to keep everyone safe, Smith did not hesitate to step in where she was needed. She worked at group homes and even volunteered to temporarily move in and shelter-in-place at two different group homes over the course of six weeks during spring 2020 to keep the men living there as safe as possible. She did not know these men prior to moving in, but she did not let that deter her from answering the call to support them and keep them safe.

"I knew my coworkers needed me, and the people needed me," Smith said. "I was all about keeping them safe. To try to prevent them and ourselves from being infected was a no-brainer."

In November, around her 50th birthday, Smith contracted COVID-19. A group of her coworkers and some people she supported at a group home also contracted the illness, and Smith spent the majority of her quarantine and recovery period worrying about how the people she supported were faring.

"Thank God everybody pulled through, and we're on the other side of this," she said. "I think Trinity did an awesome job implementing strategies and protocols to keep everyone safe, including offering vaccines on-the-job. I applaud our organization for that."

"Terra's dedication to the people she supports is evident through all of her actions — large and small — and her receipt of the 2021 Illinois DSP of the Year Award is well-deserved," said

Thane Dykstra, Ph.D., President and CEO of Trinity Services. "All of us at Trinity Services are incredibly proud of Terra, and we are grateful that ANCOR recognized Terra with this honor."

Since 2007, ANCOR's annual DSP of the Year awards recognize outstanding professionals who deliver long-term supports and services to people with intellectual and developmental disabilities. The awards celebrate the important role DSPs play in ensuring people with disabilities are included and empowered in the community, and raise awareness about a direct support workforce in crisis. Inadequate investments in this essential workforce have led to turnover rates in excess of 40 percent and vacancy rates that average 18 to 20 percent nationally.

"ANCOR and our Diamond Partner, Relias, co-present the DSP of the Year awards program each year precisely because of people like Terra. Her commitment to ensuring the inclusion of people supported by Trinity Services enriches not only the lives of those individuals, but the broader Illinois community. Without committed direct support professionals like Terra and all of this year's outstanding award recipients, people with I/DD would have severely limited opportunities to be part of the community," said ANCOR CEO Barbara Merrill.

Someone You Should Know Mollie Horner-King

"I'm most proud of the changes I've helped make in people's lives."

nspired by helping others receive the support they need to overcome challenges, Mollie Horner-King takes on each day ready to help.

As the associate director of the Illinois Crisis Prevention Network's (ICPN) Carbondale team, Horner-King oversees a team of seven clinicians and one office assistant who typically help support 100 people over the course of a year.

ICPN is a collaborative partnership between Trinity Services and Hope that provides community-based services and supports to adults and children with developmental disabilities, many of whom are dully diagnosed with a mental illness, who are experiencing complex behavioral or medical challenges. Referrals are generated by the Illinois Department of Human Services' Division of Developmental Disabilities.

ICPN has six teams that cover the entire state. The Carbondale team supports the southernmost part of the state up to a line roughly between St. Clair and Lawrence Counties. Horner-King has overseen this team for approximately nine years. She started out as a behavior analyst and was soon promoted to associate director.

The team begins each week by meeting with sister teams to discuss statewide matters. Then, the Carbondale team meets to assign new cases and discuss any obstacles of current cases. With each new case, clinicians do intake assessments to determine what a person is struggling with, where they live and how long they've lived there and what the provider has already tried to help

the person.
In addition to providing guidance to the team, Horner-King keeps an active

caseload of her own, going into the field to support people where they live and assist their existent support systems. For example, she might work with someone in Anna, Ill. on a Tuesday and then travel to assist someone in Mt. Vernon, Ill. on a Thursday.

"It's really what I like to do," she said. "I like to provide direct behavior analysis services. ... I'm most proud of the changes that I've helped make in people's lives. What I find to be the most fulfilling part of this job is working with staff and caregivers on changing behavior, and when you really get to see a behavior support plan work and get to see a person's behavior change, that's the most rewarding part of this job."

Prior to her work with Trinity Services, Horner-King worked at a children's hospital in Louisville, Ky. for children dually diagnosed with a developmental disability and a mental illness, did behavioral consultation in a community setting, and was a clinical instructor at Southern Illinois University, supervising graduate students in the implementation of applied behavior analysis therapy. Born in Cookeville, Tenn., Horner-King earned her bachelor's degree in psychology from Tennessee Tech University, and her master's degree in behavior analysis and therapy from Southern Illinois University.

Horner-King was inspired to pursue psychology after taking her first undergraduate class on the subject and falling in love with it. She initially started out her undergraduate education studying nursing but soon discovered it wasn't for her. Wanting to be in a helping profession, she switched to early childhood education, which is where she discov-

ered and made the switch to psychology.

Later on in her career, her grad school advisors, who worked at Trinity before teaching at SIU, encouraged her to apply for a job with the organization.

"Mollie has assembled an outstanding group of professionals on our Carbondale team due to her strong leadership skills," ICPN Support Services Team Director Kim Shontz said. "Mollie remains calm in the midst of chaos and uncertainty. She never hesitates to advocate for the children and adults receiving services. She has great insight to what is happening across the southern region and statewide. She is dedicated to improving the services available to people and their and families, and strengthening the DD system across Illinois."

Horner-King said she enjoys the variation of her job the most.

"It's always changing and always dynamic," she said. "The criteria for someone to receive our services is just that they be diagnosed with a developmental disabilities. That means we end up working with a wide variety of clients. I really like that."

Outside of being able to make an impact in people's lives, Horner-King said she is proud of earning the Outstanding Manager Award from Trinity Services three times during her career with the organization and coauthoring scientific journal articles.

In her free time, Horner-King enjoys spending time with her husband and daughter. She is very involved in her daughter's life, volunteering with her middle school as the volleyball coach and softball coach.

Illinois includes \$170M in budget for disability services Thank you for your support, advocacy this legislative session

his legislative session, the Illinois legislature passed a budget that includes an increase of \$170 million in funding for community developmental disability services in the state.

This is a huge win for people with disabilities and for organizations like Trinity Services that support people to live the lives they choose.

This budget increase helps fund recommendations made by workgroups regarding the state's service delivery system and funding, as well as by the independent firm Guidehouse, Inc., which completed an independent study in December 2019 detailing the level of state funding needed to stabilize residential and community day services throughout the state.

The study recommended an investment of \$329 million to meaningfully fund and stabilize services, and this \$170 million budget increase will help move disability services forward toward that mark. This funding increase will

help bring the state into compliance with the Ligas Consent Decree and will ultimately mean increased funding for staff members' wages. This is fantastic progress for the people Trinity Services supports, the organization and all providers of developmental disability services in the state.

The increased funding requires federal approval, so it is not likely that Trinity or other community organizations would receive additional funding before Jan. 1, 2022.

It is the hope, at Trinity Services, that this funding will make an impact on the workforce crisis, helping us recruit, retain and fairly compensate talented staff members who care about helping people with disabilities flourish and live full, abundant lives.

Trinity Services would like to thank all of its friends who engaged in advocacy efforts this legislative session and helped achieve this investment in services. Thank you to all who communicated the necessity of full funding for disability services to legislators and spread the word about advocacy alerts to friends. Together, everyone's voices were amplified.

There will be more work to do in the future to obtain full funding for community disability services, and there will be more opportunities to take action to advocate for this funding. Particularly as the minimum wage and the living wage continue to increase, it is important that wages for direct support professionals and other staff members keep pace.

This was Trinity Services' first inperson fundraiser since the start of the pandemic in March 2020, and the organization was incredibly grateful and excited to sell out the course.


A special congratulations goes to winning foursome Grant Barker, Tyler Barker, Loren Burkey, and Craig Slowik, with a score of 59.
