A Message from the Director

Year with no budget averted

Like you, I am relieved that lawmakers in Springfield reached a compromise in creating a stopgap budget. The State of Illinois avoided going a whole year without one, an event that has not happened since the Great Depression. The lastminute flurry of activity in the legislature and the Governor's office left us certain of only one thing: a total disaster has been averted.

Through our joint efforts and the work of many supporters, one significant improvement for persons with developmental disabilities or mental illness has moved closer to reality. The Illinois House voted to raise the DSP wage rate to \$15 an hour (House Bill 5931). Then Senate Bill 2952, the companion bill introduced by Sen. Heather Steans, was passed. Now we must continue to urge the Governor to sign the bill into law.

From the general public's perspective, lawmakers ensured that basic education and human services needs are funded, along with essentials like medical care, police and fire protection, and roadwork projects. From the perspective of a (continued on pg. 2)

person with developmental disabilities or mental illness, the compromise ensures the disbursement of federal pass-through funds, just as lawmakers did last summer for 2016.

No new revenues are included. That leaves many community service providers with difficult choices to make or, in some cases, no choice but to discontinue a program.

So, will 2017 be a better year? Will the deficit grow? Will taxes rise? These issues are still unclear. A picture has emerged of two budget visions—one from the Rauner Administration and one from the rank-and-file legislative working group. The two do not seem terribly far apart, and both sides appear willing to work on issues such as tax reform.

Right now, the new budget is 65% completed. One can imagine that, if legislators feel enough heat from constituents, they will complete the full-year budget in January. By then, elections will be in the rearview mirror and the work of crafting a 2018 budget will be approaching fast.

We will keep you informed of changes that occur as a result of funding shifts.

Witness slips boost support for DSPs

This spring, Trinity mobilized 939 people to tell the Illinois General Assembly that Direct Service Professionals (DSPs) deserve a living wage.

Supporters of the law are fortunate to have an efficient, new method for telling lawmakers about their wishes. In March of 2012, the legislature began offering online witness slips as a way for citizens to participate in the legislative process. Previously, citizens had been allowed to give input during a committee hearing. But, the input took the form of public testimony. During the hearing, the committee chair would read aloud the names of the witnesses who filed a slip of paper for or against the proposal.

Now, Illinoisans can quickly weigh in without testifying. A witness slip is sim-

ply a person's or group's position on a bill. It can be filed for any bill, and it can be filed on behalf of oneself or an organization. The Senate and House have different rules, but both consider this form of input official state documentation.

The Senate allows you to submit a witness slip up to the end of the day of the committee hearing's scheduled date. In the House, you can submit a witness slip up to the end of the committee hearing.

The online option is critical for increasing public



participation. With a state the size of Illinois-57,915

square miles—it is impossible for most citizens to drop what they're doing and attend a hearing.

Research shows that the Internet has increased participation in civic life-the business of learning about and influencing how our democracy works. Unfortunately, the data also shows that our participation levels are unbalanced. Folks with higher incomes are participating more frequently than those with lower incomes.

Witness slips are an excellent tool for citizens with fewer resources. Only a smartphone, or brief access to a computer, is needed now to influence lawmakers at these critical moments in the legislative process.

Trinity will continue to encourage its supporters to participate online in legislative proceedings. The site to visit for witness slips is http://witnessslips.ilga.gov.
